1. Application

1.1 Information about the initial accreditation process

The Faculty of Security Studies at the University of Banja Luka applied for the issuance of a licence for the second-cycle study program of the Security and Crime Studies to the Ministry of Scientific and Technological Development, Higher Education and Information Society of the Republic of Srpska (hereinafter the Ministry). After reviewing the submitted documentation and concluding that the application was valid, the Ministry requested the opinion from the Council for Higher Education of the Republika Srpska (hereinafter: the Council). After obtaining a positive opinion from the Council under document number 19.040/020-3707-44/20 from October 26, 2022, the Ministry submitted to the Agency for Higher Education of Republika Srpska (hereinafter: the Agency) a request for external evaluation for initial accreditation of the Security and Crime Studies study program which was received on November 1, 2022 under protocol number 1/01-04-1-494/22. The Director of the Agency appointed Jugoslav Vuk Tepić, PhD, as the external evaluation procedure's coordinator for initial accreditation by Decision No. 1/01-04-1-494-1/22 on November 1, 2022. On November 8, 2022, the Agency signed a contract with the University of Banja Luka for external evaluation services for initial accreditation of the Security and Crime Studies study program under number 1/01-04-1-494-2/22. The Review Panel for external evaluation was appointed from the List of reviewers of the Agency by the Decision on the appointment of the Review Panel number 1/01-04-1-494-3/22 on August 30, 2022, and Decision number 1/01-04-1-494-13/22 from November 18, 2022. After concluding the contract with the members of the Review Panel and signing a statement on the absence of conflict of interest all of them were individually provided with data for logging into the Agency's information system where the documentation proving the fulfilment of the standards for initial accreditation is posted and a checklist was set up in which the members of the Review Panel entered all preliminary findings and observations and thus prepared for a visit to The Faculty of Security Studies. The process coordinator informed the members of the Review Panel about the technical details of the visit, the time frame for all phases of the external evaluation, as well as the recommended work methods for the efficient and timely execution of obligations. Also, the



tentative date for the visit to the higher education institution was agreed upon, and the manner in which the members of the Review Panel prepare all the steps during the upcoming cooperation was agreed upon.

The Review Panel analyzed the submitted documentation, prepared for the visit, and through direct inspection during the visit to the Faculty of Security Studies at the University of Banja Luka in the period from December 26 until December 27, 2022, checked the validity of the evidence of fulfilment of the requirements of the Standard for initial accreditation. The day before the start of the visit, December 25, 2022, a meeting of the Review Panel was held during which the work method for the visit was agreed upon. On the first day of the visit, the Review Panel spoke with the management of the University, i.e. the Faculty of Security Studies, the head of the Security and Crime Studies study program, and the academic and non-academic staff of the study program. This was followed by a tour of the premises and facilities of the Faculty of Security Studies, which will be used to run the Security and Crime Studies study program. On the second day of the visit, December 25, 2022, the Review Panel presented a preliminary report to the management of the Faculty of Security Studies, without announcing the outcome of the external evaluation for initial accreditation and without the possibility of commenting on the preliminary report by representatives of the Faculty.

2.0 External evaluation

2.1 Previous activities

During the preparation for the visit to the Faculty of Security Studies at the University of Banja Luka, the Review Panel analyzed the submitted documentation, made notes, remarks and comments into the Agency's system, and prepared a list of questions that would be asked during the visit. Acting by the agreed scope of work, the Review Panel made complete preparations for the visit to the Faculty (recorded on the individual accounts of the reviewers in the Agency's system, subject -SP Security and Crime Studies, Faculty of Security Studies UniBL) for external evaluation in the process of initial accreditation, in the agreed period, from December 25 until December 27. The day before the start of the visit, on December 25, 2022, a working meeting of the Review Panel was held and the details of the visit were agreed upon. The details of the visit have been agreed upon with the Faculty of Security Studies and are listed in the document Review Panel Work plan and Program of the Visit to the Higher Education Institution.

Also, a Study Program Review Report can be found in the Agency's system which is prepared and integrated into the Final External Evaluation Report for initial accreditation of the study program in question.



2.2 On-site visit to the higher education institution

On the first day of the visit, the Review Panel spoke with the representative of the University and the management of the Faculty of Security Studies, the head of the Security and Crime Studies study program, and the academic and non-academic staff who will be engaged in the operation of the study program. Details about the participants of all interviews are part of the documentation of the external evaluation and are available at the Agency.

All the aspects of the organization, management and providing the necessary resources and funds to operate a study program were discussed with the management of the higher education institution and the faculty. The study programme should be up to date with a particular emphasis on the need for cooperation with the labour market in the broad sense, that is, cooperation with private organizations that have a need for graduates and to expand a scope through the contracted and project needs of the public security system, that is, the institutions of the Republic and the joint institutions of BiH.

This was followed by a tour of the premises and resources of the faculty which showed everything that was stated in the documentation in terms of support of the teaching and scientific and practical part of the study program, from the appropriate classrooms to the shooting range and IT classrooms. The faculty equally pays attention to the practical and theoretical part of the training of future graduate students but also emphasizes the insistence that their students maintain both, mental as well as physical fitness, that is, the concept of "in a healthy body, a healthy spirit", which is quite adequate to the profile of future graduates.



2.3 Evidence of meeting standards for initial accreditation

Information about the higher education institution

In the section containing Information about the higher education institution, very precise data are given that initially refer to the establishment of the University in Banja Luka, and then statistical indicators on the number of employees, visiting professors, associates and the number of students at the University. The text provides information on the publishing activities of the University as well as on scientific results and scientific meetings, exhibitions and other events where achievements in science and culture are presented and exchanged. Particularly significant is the adoption of the Development Strategy of the University of Banja Luka from 2017 to 2025, considering that the practice of adopting this kind of document at universities in the region is not that widespread. This document, precisely through the clearly stated strategic goals and sub-goals, points to the need to establish internationally recognized master's and doctoral studies, which must be better integrated as second and third-degree studies. The most important characteristics of an independent higher education institution (university) are presented concisely and clearly. Comparative advantages in relation to other higher education institutions are expressed by quantitative (number and competence of teachers, associates and technical staff; the number of students at all levels of study; the spatial arrangement of University members; facilities and other material resources, etc.) and qualitative indicators (international cooperation; membership in networks and associations; awards for excellence, etc.). The university shows commitment to the fundamental values of education, higher education, science and research, which is confirmed by the presented arguments and evidence.

Data are given on the number of study programs, where it is stated that there are 64 study programs (in the first cycle of studies), 66 programs in the second cycle and 15 study programs in the third cycle of studies at 17 faculties. Then, the information on international cooperation is very well stated, with over 100 active agreements signed at the level of the University and over 150 agreements signed at the level of organizational units. The largest number of agreements were signed with partners from the countries of the region, with partners from EU member states, with partners from countries that have special relations with the EU even though they are not members, then with partners from the Russian Federation and the People's Republic of China, as well as with several partners from other countries worldwide. Information related to the workspace of employees and students is very important. It is stated that the total area of classrooms of about 16,000 m2 and laboratory space of about 10,000 m2 is available. The university has 20 computer rooms with constant internet access. The libraries have around 185,000 books, and they subscribe to 75 scientific journals. In conclusion, plans for further development and advancement are stated.

Information about the study programme

The study programs at the Faculty are diverse and substantive, adapted to the needs of the modern teaching process. Master's academic studies in Security and Crime Studies will be the only ones in these narrow scientific fields in the territory of the Republic of Srpska.



Specialists who will perform complex tasks in a sphere of great social importance will be trained here. By accrediting these studies, the Faculty shows that it has correctly recognized the needs of the labour market and that it is ready to make available its scientific and teaching resources for the creation of highly educated personnel ready to be included in the work process in competent bodies, agencies and other organizations, but also in the field of private security. This would allow students to complete their scientific and professional training within the Republika Srpska, instead of going to universities in neighbouring countries. The proclaimed goals of the study program express adherence to the principles of the Bologna Declaration and modern education and are aimed at developing independence, critical thinking and practical knowledge.

When it comes to the reasons for the establishment, goals and tasks, they are not clearly and precisely presented in the Elaborate. It is necessary to notice the difference between the first and the second cycle of study. The wording, that "modern challenges such as the migrant crisis, terrorism, threats to the economic security of citizens, and other forms of threats to well-being, indicate the necessity of introducing a second cycle of studies in the scientific field of security and crime studies" does not say anything specific about this connection and necessities. Namely, there is a lack of a description of these phenomena, which, for example, due to their complex structure, new forms and manifestations, require new supplemented knowledge, new theoretical and practical approaches with new technological skills and abilities, thanks to which the graduate students will better understand and react better, that is, solve these problems in the future. In accordance with the above, there is a lack of formulations, such as: - a wider range of professional knowledge - advanced knowledge (higher level of knowledge about specific theories and practical topics) - more specialized studies than basic studies, with greater depth of knowledge about certain phenomena - professional and analytical solving of complex problems and tasks higher level and better application of technological knowledge and skills.

Despite certain ambiguities in the formulation of basic goals and tasks, the overall impression is that they are well thought out, achievable and sustainable, substantiated by the submitted documentation and further confirmed during the visit to the higher education institution seeing all the resources available to the Faculty.

The strategic documents studied by the Review Panel represent a very solid normative basis for quality management in the implementation of the teaching and research process and leading a responsible and sustainable development policy of higher education institutions. The Strategy, as well as the Amendments to the Statute, are designed to include all necessary elements of the University, and above all, goals with clearly defined key strategic directions and frameworks that promote the highest academic standards in higher education. The amendments to the Statute of the University in 2017 fulfilled the



requirements for the establishment of a new organizational unit - the Faculty of Security Studies, which, after the successful accreditation of basic academic studies, also initiated the process of accreditation of the II-level of master's studies.

In this regard, the university and the faculty as its constituent organizational units are fully compliant with laws, other regulations and general acts, as well as standards and good academic practices. The goals and objectives are completely and clearly established.

The concreteness, feasibility and measurability of the goals emerge from the available documentation. The goals are set responsibly and reasonably, taking into account real academic, material and other resources, market indicators and the wishes and plans of future graduates.

The Statute of the University of Banja Luka from 2022 also brought some novelties compared to the previous one. One of them also refers to the possibility of disposing of funds, where, according to the new provision of the Statute, the possibility is opened for the Board of Directors and the rector of the University to dispose of these funds with the prior consent of the university member's dean, which denies a part of the member's autonomy. Also, the powers of the rector are significantly wider compared to the previous Statute, which now implies that the rector can suspend from execution the decision of the dean of a member of the University, which also partially limits the independence of the university member.

Guideline 1.1.

In the above-mentioned Elaborate, in the part that refers to the alignment of the goals and objectives of the study program with the needs of society and the labour market, it is not clear what the market's needs are exactly for master's students and the different job positions they would occupy in the mentioned institutions and organizations, and in relation to graduated students of undergraduate academic studies. We can assume that these are some decision-making positions, hierarchically higher than those that are intended for



graduates of undergraduate studies, positions that require greater professional knowledge and carry greater responsibility.

In conversations with representatives of the Faculty administration and with academic and non-academic staff, the real needs of the labour market for personnel with an academic master's degree were presented and additionally documented. Expected systemic, legal and organizational changes and expected developments in the sphere of security were also pointed out. Staff training at higher levels of study is an indisputable need of the broader social environment and employers in the public and private sectors.

The study program was created in accordance with prescribed and default quality standards, norms and practices.

The study program was developed in accordance with the Instruction for creating and improving study programs. The suggestion is made in relation to the aforementioned Instruction that was adopted in 2011, and in this connection, it is recommended that a new one be adopted in the near future in accordance with new approaches and standards, the outlines of which are already visible in foreign academic circles. New approaches and standards refer to, among other things, secure access to electronic information, adequate electronic communication services, learning environments (physical, virtual and blended) and related learning activities that support academic interactions among students and outside of formal classes, better access to learning resources, taking into account costs or technological requirements, including special categories of students (with disabilities, part-time students, etc.), developing opportunities for self-accreditation and many others...

STANDARD 1. Goals and core tasks of the higher education institution

STRENGTHS:

The need to introduce a new study program for academic master's studies is obvious. The faculty demonstrated its readiness and ability to meet the standards and requirements of good academic practice. The absence of academic master's studies in this scientific field is a gap in the education system of the Republic of Srpska that needs to be filled with a quality and sustainable study program. The curriculum enables comprehensive, theoretical and practical training of students. The purpose of the program is to upgrade previously acquired education, that is, to ensure continuity and progress in the acquisition of scientific and professional knowledge and skills.

Internal normative and strategic documents precisely describe the processes, procedures and resources included in the quality assurance system.

The entire quality assurance mechanism at the University of Banja Luka includes all necessary regulations from laws, standards, strategies, statutes, regulations, procedures and criteria, to forms and accompanying activities, it was only noticed that some were updated and adopted as completely new documents in the last year or two, while some are older than 10 years, so in this regard, some kind of activity is recommended to update/adopt new versions, adapted to the needs of the time and circumstances in which academic activities are carried out.

Internal acts precisely, in detail and concretely determine the responsibilities, obligations and powers of all entities involved in the quality assurance process. Powers and responsibilities are properly distributed so that they enable economical and efficient management of the quality of the processes carried out in the higher education institution.

When it comes to the quality coordinator, it is not clear enough how he is chosen, who appoints him and whether there are any criteria he must fulfil (I could not find them in the mentioned documents). In most other organizational units (faculties), it is a person from among the teaching staff, in this case, it is the head of student services. Maybe it's nothing controversial, but it needs to be clarified further.

Doubts that the Review Panel had regarding the sustainability of the coordinator's role were removed after familiarization with the actual circumstances of the work and the way the



coordinator fulfils its obligations. The head of student services proved to be a good organizational and personnel solution, and the implementation of measures, plans and procedures for quality assurance showed good results.

STRENGTHS:

The general acts of the University and the Faculty prescribe procedures, measures and actions that ensure compliance with quality standards in the achievement of strategic and specific goals. Strategic documents are accompanied by concrete procedures, which define the parameters for monitoring continuity in the achievement of quality. A solid and coherent normative framework guarantees objectivity and measurability in the realization of quality indicators. There are prescribed forms, designated persons for coordination and clearly defined tasks, roles, authorizations and obligations of participants in the process of achieving and maintaining quality.

Based on the Rulebook on the internal organization and systematization of workplaces at the University of Banja Luka, it was observed that the Faculty of Security Studies, among others (not necessary), lacks the following positions: - head of the library - p. 82 - network administrator p. 83 - associate for the preparation of projects and promotion of the Faculty, p. 84 - guard/porter - p. 84

Despite the observed shortcomings, the Review Panel determined that the existing organization and systematization of workplaces enables the smooth functioning of the institution and provides a solid basis for the development of new study programs.

Considering that it is an organizational unit of University of Banja Luka that has been successfully operating, the existing management bodies take care of all aspects of the



organization, and the Law on Higher Education published in the Official Gazette and the Statute of the University of Banja Luka are attached.

In the Statute of the University of Banja Luka, there is Article 4, which also defines these items: 3) election of management bodies; 5) independent development and curricula and research projects; 8) organization of studies, creation of study programs, knowledge assessment and issuance of diplomas and other public documents. The organizational units that are visited and the responsible persons are listed in the On-site visit to the higher education institution, as well as the contact persons.

Based on the reviewed regulations, such as laws, rules, decisions, regulations, rulebooks, forms and similar documentation, it can be said that the requirements for the initial accreditation have been met. Most of the mentioned documents are recent and in accordance with the current processes in higher education. Any document that is older than 10 years may in the following period be the subject of updating or issuing a completely new document, in order to meet the requirements and criteria of time, circumstances and potentially new conditions of study (for example, Instructions for the development and improvement of study programs, 2011).

Security and Crime Studies, the second cycle academic study program, is structured as requested and all details are provided in the documentation with supporting evidence.

The structure, goals, tasks, competencies of the graduated students and other indicators of the justification of the introduction of the study program are convincingly presented.

The Review Panel carefully analyzed all aspects of the study program. Goals and objectives are achievable and sustainable. Course syllabi are modern and adapted to the needs of the labour market. Learning methods and outcomes are aligned with modern teaching, pedagogical and scientific principles. The methods of knowledge assessment as well as the procedures and enrollment policy are in accordance with the standards and practices in the wider academic community.

The note already given earlier, it is only repeated and refers to the new version of the Instructions for the development and improvement of study programs, especially bearing in mind the need and ambition of various members of the University of Banja Luka to accredit new programs at all study levels in the near future.

The study program is in all respects in accordance with the analyzed standards of the institution's functioning. Other study programs form a natural and logical whole with the proposed master's academic study program.

No inconsistency was observed between the proclaimed goals of the study program and its structure, content, and designated methods of implementation.

In this regard, the study program is fully compliant with regulations, standards and norms. At the University level, there is a normative framework that governs relations and activities according to this requirement.

Individually, there is a clear correspondence of the Security with similar master's programs in Sarajevo, Belgrade and Skopje and Crime Science with the same study programs in mentioned universities. The normative framework is clearly presented. The planning of science and research activities is carried out in accordance with the options and limitations of the external environment (normative and social).

The fund for the encouragement and promotion of scientific research activity is a good idea, but the funds can also be expanded to some other useful activities. For example, when an invitation is received to give a lecture at an international conference, the organizer provides all the funds for the invited lecturer, so it is not necessary to allocate additional funds from the Fund. Also, it is more necessary to provide funds for the publication of indexed scientific papers in international journals, where it is necessary to pay for publication, because such is the policy of the journal, than to reward the lecturer, who managed to publish that paper.
